The speeches must be the result of experiences, applications, theoretical research and/or empirical or innovative deployment models.







- Original, relevant, and professional rigor developed and/or academic.
- With an audit focus, accounting strategies, business strategies, innovative ideas applicable in the administration of public or private sector.

Formal Requirements

The Speech should be sent to a double-blind review. The Speeches presentations that include the following shall be accepted:

Front page should include:

- Secondment institution
- Work title
- Name of the author and co-authors with email and phone numbers
- Selected theme
- Date and place of the congress







The Speech should include:

	Abstract of 200 words maximum
	Three keywords.
	Identification of the Problem or Issue Goals
	Justification
	Contents of the Speech with numbered pages focused on the bottom, having as heading the title of the Speech.
]	Arial script 12 points, 1.5 line spacing, margins 2.5 cm and 0.5 cm left indent. in the first line of each paragraph.
]	Work must contain a minimum of 12 pages and a maximum of 20, considering abstract sheet, graphs, tables, references and any attachments.
]	The sheets must be numbered in the central part of the lower one centimeter margin.
Γ	References: Use "APA Format 6th Edition" for citations in the text and references.

Evaluation of Speeches

Papers will be evaluated under a review process double-blind scientific rigor.

Evaluation results

The results of the evaluation of the Speeches will be sent no later than 7th to 10th June 2016.

Indications for accepted Speeches

After being accepted the speeches, the speakers should send the file to the letter assignment of copyright so they can be included in the corresponding book (all authors of the speech must sign the letter) and make the corresponding payment.

The format for the transfer of rights and emails corresponding to the above indications will be provided upon acceptance of the paper.







Accepted Speeches will be published in a printed book with ISBN register as long as the payment is made and attendance is confirmed.

The inclusion of speeches in the book will be presented in the original language and delivered one in each speech. The request for more books would involve additional costs.

In case of being accepted the speech, but with observations or comments by the jury, they are forwarded to the author, to be incorporated into the text in the term indicated.

Important Dates

Period for receiving speeches: March 28th to June 6th 2016.

The date for sending the letter of transfer of copyright will be sent no later than June 13th 2016.

The date for payment will be as limited on June 13th, 2016 and made the payment of the account that you specify in the mail acceptance speech. In case of not paying his speech will not be considered for the Congress or for the publication of the book.
